#### 6.0 Treasurer's Report

6.1 The Treasurer advised Council that the Association was continuing to be financially sound. The income from the advertising so far in 2025 was £4852.00

Balances on the accounts were as follows:-

Current Account: £22,917.18

Business 1 year Bond: £39,239.91 (matures in Jan 26)

Business 100 day Notice: £34,720.87 (interest added on 31/10/25)

The Treasurer reported that due to the uncertaintenty regarding a couple of branches he did not propose to invest further in the 1 year bond when it matured in January 26

### 7.0 Membership Secretary's Report

- 7.1 The Membership Secretary informed the meeting that he only received 10 returned copies of NARF News. He asked that Branches continue to keep details of members addresses as accurate as possible so NARF News returns continue to reduce.
- 7.2 The Membership Secretary reported that 19 new applications had been received from the website but only 3 had been returned so far. At the end of 2025, three branches (160 members) would be closing due to lack of volunteers to take on secretary and treasurer.

## 9.0 Editorial Committee Report

It was proposed that the draft magazine would be sent too the shop manager and the President for ratification before going to print to ensure changes to the shop prices were amended to save losing money on postage.

They were also reminded that failure to respond to written requests and to answer joining questions would prevent them joining the Facebook group. ## 12. Shop Manager

12.1 The Shop Manager reported that sales were much the same as last year. He had changed to EVRI for deliveries as the Post Office were getting expensive and losing too many items.

#### 13. Report of Firefighters Memorial Trust. (FMT)

There was no report from the FFMT. It was agreed that the secretary contact a Direct Member who was also a trustee so that the Association could maintain contact with the Organisation.

#### 14.0 Any other business

- 1. The Secretary advised the meeting that the annual service held at the FF memorial in London was now being organised by the London Fire and Rescue Service. It was agreed to write to the Chief Fire Officer requesting the the Association receive an invite to the ceremony.
- 2. The Secretary queried the use of Branch secretaries private email addresses being published on the website (albeit with their agreement) He suggested that each Branch should have a Narf email address. It was agreed the President with issue guidance on how to create this.
- 3. Rewards for Rescue. The secretary had been advised of the organisation offering discount to emergency workers. It appears this is in addition to the blue light discount. The secretary had written to the organisation requesting full details before recommending it to the Association
- 4. A bench originally supplied by No 2 District, and sited outside Durham Cathedral had been refurbished and a donation made to the cathedral. It was suggested that an article in the next issue of Narf News might encourage other Districts to do likewise.
